About this Document

In June 2018, Oracle announced that after January 2019, commercial users of Oracle JDK will need to purchase an Oracle support contract in order to continue to receive updates. Oracle also changed its licensing so that any commercial production usage of Oracle JDK, starting with version 11, will require an active Oracle support contract.

This document will guide you through the uncertainty and additional financial burden this decision by Oracle has brought.

THE CHANGING JAVA LANDSCAPE

As of January 2019, Oracle has announced that Java SE public updates will no longer be available for "Business, Commercial, or Production use" without a commercial license.

WHO WILL BE AFFECTED BY THESE CHANGES?

All commercial Java users, not just legacy Oracle customers, will be impacted by this change.

Java has been one of the key technologies in the enterprise for decades and it is relied upon for the flexible and extendible architecture that can scale across almost any device or platform. It has a vibrant Open-Source community that spans across the entire planet.

Oracle has recently brought instability and uncertainty to the Java ecosystem with their new non-open-source licensing model which has many Java users evaluating their needs and their increasing reliance on Oracle.

Commercial users of Oracle JDK will need to purchase an Oracle support contract in order to continue to receive updates and be properly compliant & licensed in non-development environments.

RED HAT OPENJDK FOR LINUX AND WINDOWS

As many organizations rely on Red Hat Enterprise Linux for their workloads on-premise and in the cloud, Red Hat is uniquely positioned to aid customers with these new volatile licensing models set by Oracle.

For nearly a decade, enterprises have benefited from using Red Hat's supported OpenJDK that is included in every Red Hat Enterprise Linux and Red Hat Middleware subscription. In addition, Red Hat launched a supported Red Hat build of OpenJDK for Windows Servers and Workstations that is available as a subscription.

Customers who currently run Java applications using OpenJDK on Red Hat Enterprise Linux or with a Red Hat Middleware subscription are already fully covered and compliant.

Those who are not currently using OpenJDK or require Java support for Windows workloads have a series of crucial decisions to make around the use of Java in their environments in order to stay compliant under the new Oracle Java non-open-source licensing model.


